




Independent terminal as gateway from and to many different destinations







From unloading of vessels, temporary storage and send out of liquid CO2 in different modalities









The terminal will be located at the Maasvlakte in Rotterdam at the premises of the Maasvlakte Oil Terminal (MOT) and Gate terminal.






